

# FEEDLOT MEMBERSHIP

**The Australian Lot Feeders' Association (ALFA) is the peak national body for the Australian Feedlot Industry, providing leadership and services to ensure a sustainable and prosperous Australian grain fed beef industry.**

Applicants for Feedlot Membership must be the Operating Entity of an NFAS Accredited Feedlot, and be responsible for managing the day-to-day operations. There are several benefits associated with being a Member of ALFA. Members are afforded discounts to ALFA-run initiatives and training programs, and have access to member exclusive communications. **The ALFA Membership year runs from 1 July to 30 June.**

### Candidates for Membership

Under Sections 5 and 7 of Articles of Association of ALFA:

5. Subject to these Articles of Association, a person may only become a Feedlot member of the Association if, in the opinion of the Council, the pre-requisites of Feedlot membership under these Articles are satisfied provided that each Feedlot member shall register with the Association from time to time all Feedlot properties of which he is the legal or beneficial owner or lessee.
7. (c) A candidate for membership may be elected or appointed respectively by a majority of the Council who shall if so requested by the candidate or any member of the Council proceed by secret ballot. In no case shall the Council be required to give any reason for the rejection of a candidate.
7. (d) On the election or appointment of a new member the Executive Director shall notify the fact of election or appointment to that member in writing by prepaid letter sent to the address given as above required and request payment of the annual subscription and levy for the current year in respect of each registered property in the case of Feedlot members and annual subscription in the case of other members. In the event that the new member is elected or appointed on a date other than 1st July then the aforesaid annual subscription and levy for the first year shall be the amount of such annual subscription and levy pro-rated on a daily basis for the number of days between the date on which the new members is elected or appointed and the following 30th June.
7. (e) Despite his election or appointment as a member, no newly elected or appointed member shall be entitled to enjoy any of the rights, privileges or benefits of membership of the Association until all such payments have been made; when made he shall become bound by the Memorandum and Articles of Association of the Association. If such payments are not made within one (1) calendar month from the date of the posting of the aforesaid notification by the Executive Director, the election or appointment as a member shall be void.

## MEMBERSHIP FEES

### Calculation of Membership Fees

Membership fees are calculated according to the lesser of the feedlot(s) actual physical capacity and the feedlot(s) licensed capacity as at July 1. Please ensure ALFA has the correct feedlot capacity recorded within your membership details at time of application and that you notify ALFA if your capacity changes.

A feedlot with capacity of 500 head or less pays a set base fee of \$500 (excluding GST).

If the capacity is greater than 500 head the membership fee is calculated by multiplying the feedlot capacity by 42¢ and then adding the base fee as outlined in the below calculation table.

A maximum membership fee of \$21,500 (excluding GST) applies to feedlots with capacities over 50,000 head.

A pro-rata membership fee applies after 1 October.
